COVENANT AGREEMENT

What is a Covenant?

The word "covenant" is defined as "a compact" which is an agreement between two or more parties.

Within the very meaning of the name "covenant" lies the essential fact that there are conditions to a covenant. A "covenant" is made up of conditions (terms of agreement) which each party has agreed to uphold, otherwise, there is no covenant. Covenants are legal documents or verbal agreements whereby oaths of faithfulness are expressed between two or more parties.

A covenant carries legal authority in which all parties are constrained (obligated) by the conditions of the covenant. It is always conditional upon each of the parties involved to fulfill their part of the covenant. There is no such thing as an "unconditional" covenant. "Unconditional" means no conditions or that anything goes. This in itself would negate the very use of the word covenant. However, there is such a thing as a conditional covenant *becoming* a "permanent" covenant after all of the conditions of the covenant have been fulfilled.

Establishing a covenant is different than *fulfilling* a covenant.

- *Establishing* a covenant is the successful agreement of the parties involved regarding the terms and conditions of the covenant.
- *Fulfilling* the covenant is the actual carrying-out of that agreement.

International Anointed Ministries (I.A.M.) is essentially an Apostolic and Prophetic Counseling and Consultation Center, with an emphasis on Kingdom of God Living and Foreign Missions. Apostolic and Prophetic Counseling and Consultation through covenant relationship lives up to its mission by developing strong relationships with pastors and their congregations in the community and around the world. We achieve this through a Covenant Agreement, which creates a partnership in ministry between I.A.M. and the church. The Covenant Agreement allows I.A.M. to become an extension of and complement to each church's ministry.

The principle that under girds all strong relationships with congregations nationwide and internationally is that the Covenant Agreement is beneficial to both the churches and to I.A.M.

How? Through I.A.M., churches in the community and around the world have access to a range of Apostolic and Prophetic counseling and consultation services and a network of resources that might be unavailable and/or unaffordable otherwise. In turn, I.A.M. is supported in its Apostolic and Prophetic ministry to the local, regional, national, and international community.

Common Elements of the I.A.M. Covenant Agreement

I.A.M. agrees to:

- Provide 24 hour access to Apostolic and Prophetic counseling and consultation services for partnering pastors of the I.A.M. community
- Maintain a competent Apostolic and Prophetic counseling and consultation staff
- Provide 4-6 hours of free Apostolic and Prophetic consultation, leadership training, or educational programming during the year
- Provide an I.A.M. Apostolic and Prophetic staff member to preach when needed
- Provide an I.A.M. Apostolic and Prophetic staff member to be a liaison to the church
- Offer other educational events (seminars, workshops, etc.) for discounted rates and/or partner registration fees
- Provide Apostolic and Prophetic consultation for pastoral staff in dealing with a variety of therapeutic and/or human relationship issues with which they are confronted
- Establish satellite Apostolic and Prophetic counseling and consultation center in the local church [when requested]
- Provide opportunities for resource management, networking, and raising funds for special projects
- Help to acquire VISAS and Passports, and other legal documents when needed
- Network with businesses, churches and ministries to support pastors in third world countries with salaries
- Network with businesses, churches and ministries to support churches and ministries in third world countries with PA Sound Equipment
- Network with businesses, churches and ministries to support churches and ministries in third world countries with Agricultural Farm Equipment and Tools

- Network with businesses, churches and ministries to support churches and ministries in third world with educational materials and supplies, clothes, and food

Partner agrees to:

- Commit to paying a minimum yearly covenant seed of \$100.00 to \$500.00 US Dollars as requested for overhead and administrative costs.
- Designate one Sunday a month to Kingdom of God Living and Foreign Missions as “A Kingdom Life” and “Foreign Missions” Sunday, providing written information on Kingdom of God Living and Foreign Missions to the membership and/or either having an Apostolic and Prophetic staff member preach or make a brief presentation about Foreign Missions.
- Make an annual contribution to the Foreign Missions Fund at I.A.M., which provides scholarship help to those needing Apostolic and Prophetic counseling and consultation, but who cannot afford the same.
- Select one Apostolic and Prophetic staff member to serve on I.A.M.’s Apostolic and Prophetic Advisory Committee.
- Designate I.A.M. as the church's primary referral source for Apostolic and Prophetic counseling and consultation
- Publicize I.A.M. in church media.
- Participate in the recruitment of churches supporting I.A.M.’s Apostolic and Prophetic counseling and consultation ministry.

Covenant Agreement Principles:

1. *There Shall Be A Weekly and/or Monthly Melchisedec Tithe From Ministry Services And Bible Study Groups That Shall Go To The I.A.M. Apostolic Leaders. Genesis 14:17-20. Ten percent of the Offerings from Each Worship Service will go to the I.A.M. Apostolic Leaders*
2. *If A Participating I.A.M. church’s Pastor / Leader Calls, Their I.A.M. Apostolic Leaders Will Be Made Available, One Way Or Another*
3. *There Shall Be Monthly Spiritual Themes Around Which Participating Pastors Will Focus Their Messages.*
4. *Participating Pastors and Their Congregations Support And Attend Special Events When Appropriate As Designated By The I.A.M. Apostolic Leaders. Hebrews 10:25*
5. *Participating Partners Pray & Intercede For Each Other And Commit To Attend Once Weekly And/Or Monthly All Night Prayer Vigils as Designated By The Sectional / Intercessory Prayer Leaders. Ephesians 6:18-20*
6. *Participating Partners Walk In God’s Love. 1 John 3:11*
7. *Participating Partners Walk In The Spirit Of Unity. Psalms 133*
8. *Participating Partners Collaborate With Each Other On Certain Partner Issues – Especially Solicitation, Recruitment And Proselytizing*
9. *Participating Partners Walk In Integrity And Sanctification, Spirit, Soul, And Body. 1 Thessalonians 5:23*
